

For Research Administrators: Working with the PI Dashboard

Working with the Updated PI Dashboard

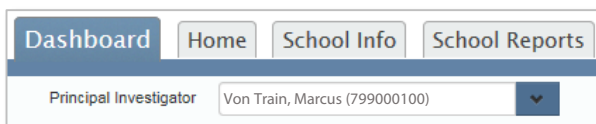
The PI Dashboard in InfoPorte has been updated based on feedback received from principal investigators across campus that they don't have easy access to financial information about their grants. The Dashboard provides a "snapshot" of grant funding and expenses, including salary projections, at both the award level and the project level. The information in the PI Dashboard is pulled directly from ConnectCarolina and is an accurate reflection of that information.

As a research administrator, you probably have more in depth knowledge about the expenses for a project. It may be helpful for you to look at the PI Dashboard at the beginning of each month to be sure the transactions that are posting to a project are correct.

Getting Access to the PI Dashboard

As a research administrator, you can get access to the PI Dashboard to see the same information as the principal investigator you support. To get access, you need to work with your InfoPorte Administrator who can grant access.

When you have access, you see a dropdown box where you can choose the principal investigator to see the same information that he or she does.



Where Does the Information Pull From?

Are you using data from the GL Actuals ledger or the Commitment Control ledgers?

Although the information on the PI Dashboard is accurate, it may not match other reports in InfoPorte. Other reports in InfoPorte, such as the ledger rollup reports, pull information only from the Commitment Control ledgers. The PI Dashboard pulls information from both the GL Actuals and the Commitment Control ledgers. If you're seeing numbers that don't match, there may be outstanding transactions that haven't yet posted to the GL Actuals ledger. Why Does the Budget Not Match?

Are you including indirect costs in your project budget?

One of the main uses for the PI Dashboard is for principal investigators to see the available balances on their grants. Most grants have indirect costs that reduce the funds available to spend. The direct budget on PI Dashboard does not include those indirect costs. The project budget on the Grant Profile tab does include the indirect costs in the project budget. When comparing reports, be sure that you subtract the indirect costs from the budget shown in the Grant Profile reports to match the direct budget on the PI Dashboard.
